- 3) In the event of unsatisfactory performance on job or any act of misconduct or breach of law, your services are liable to be terminated during the contract period of service with seven days' notice.
- 4) The payment of your consolidated pay will be subject to deduction of employee's share of contribution towards ESI and also any other deduction from pay which may come into force or becomes mandatory obligation.
- 5) You may avail 10 CL in the term of your fellowship (not more than 1 CL in a month).
- 6) If the management desires to terminate this contract of service with you, then the management will either give you one-week advance notice or one week pay in lieu thereof. In case you desire to terminate this contract of service, you may do so by giving advance notice of one month or one month pay in lieu thereof.
- 7) You will not use the data collected or any other information pertaining to this project for any other agency without prior permission of the Director, Vidya Bhawan Education Resource Centre.
