

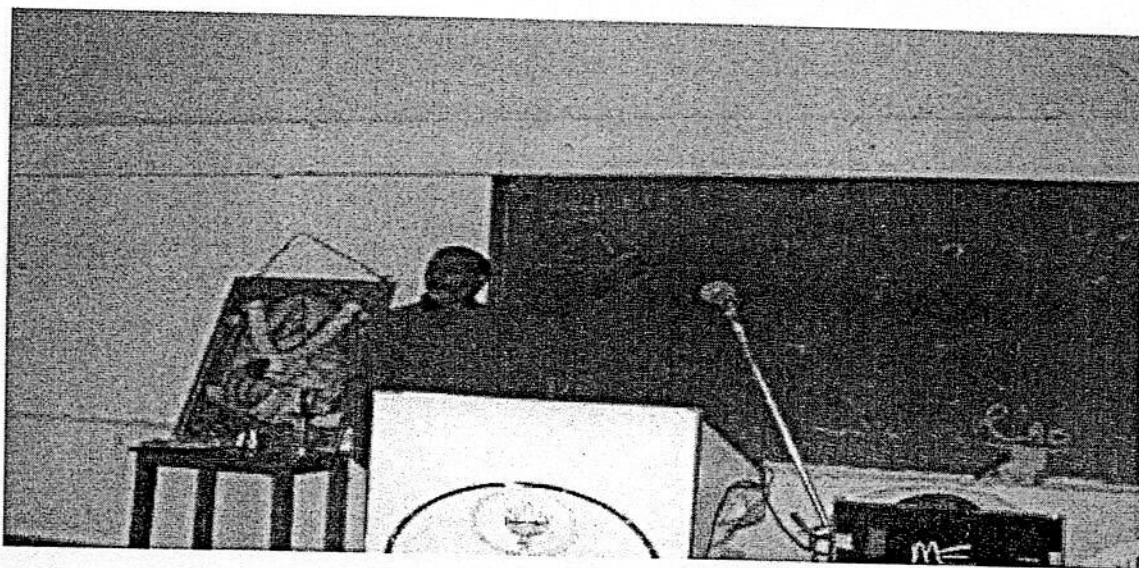


Figure 1: Photograph of speaker delivering lecture on "Business development strategies in healthcare institutions"

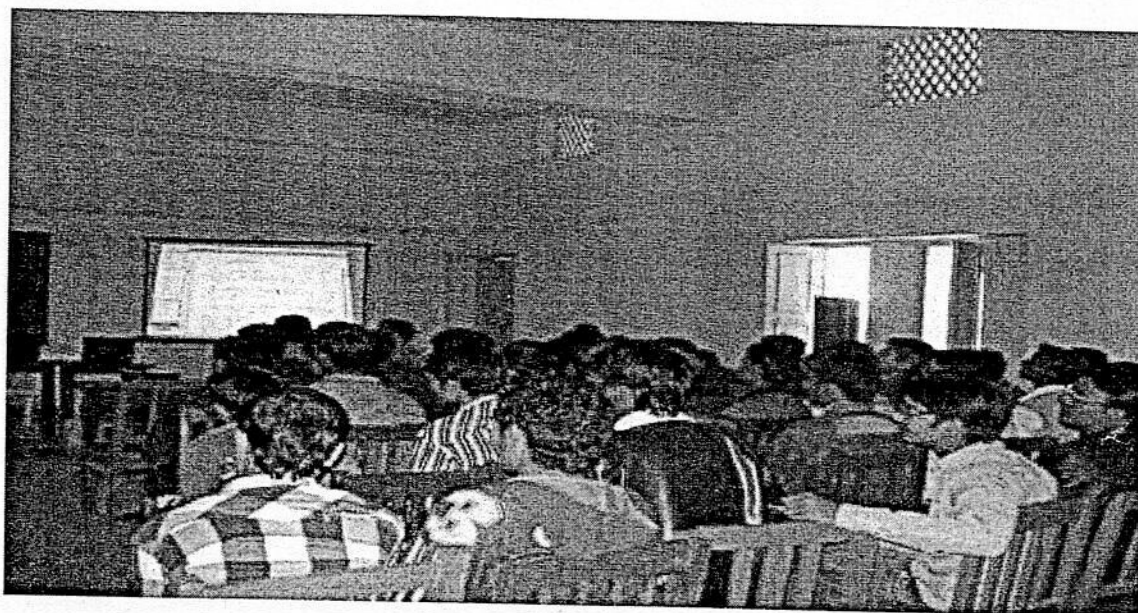



Figure 2: Photograph of Students attending a lecture on "Business development strategies in healthcare institutions"



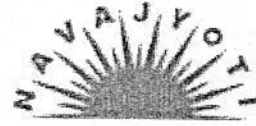


