- 2.a **Essential educational qualifications:**

Candidates enrolled for M.Sc or having completed 10+2+3 of the above qualifying examinations as on the closing date of submission of online application form i.e. 15.10.2019 (08.11.2019 for candidates of Jammu & Kashmir) are also eligible to apply under the Result Awaited (RA) category) on the condition that they complete the qualifying degree with the requisite percentage of marks within the validity period of two years to avail the fellowship.
