Where maximum permissible working pressure is reduced or the examination shows that the pressure vessels or plant or any part thereof, cannot continue to be used safely unless certain repairs are carried out or unless any other safety measures are required to be taken. The report shall be sent to concerned area officer and copy of the same to the undersigned within 7 days of completion of the examination.
5. The Institution recognized as competent person shall keep the undersigned informed the name of the competent person who leave the organization. The certificate of competency issued shall stand cancelled, if all of above named person/persons leave the organization.
6. The Chief Inspector of Factories and Boilers reserves the rights to revoke or amend this order at any time during its validity.
7. The information of testing work must be filled in proforma on RajFAB within 48 hours. Information not submitted will be considered for cancellation of Competency.


